Peace Corps and Boston University Suspend Programs in Niger FON Will Continue to Work with Local Partners

It was only a few months ago we were planning the celebration of 50 years of continuous Peace Corps Volunteer service in Niger, and then we heard that news that Peace Corps was suspending its activities in Niger for security reasons, and all in-country volunteers were evacuated. At the same time we heard similar action was taken to suspend the Boston University Niger exchange program.

Since 1962 the Peace Corps health, education, agriculture and other development programs, its volunteers, and staff have served the people in Niger. Peace Corps Volunteers have become lifelong friends and in some instances even extended members of their Nigerien host families. Similar friendships have been developed by others living, working, studying and serving in other functions in Niger including NGO staff, missionaries, students and government workers from ambassadors to secretaries. The personal ties and commitments developed between people are not to be broken by the suspension of a program.

For almost 48 years, countless lives have been changed and positively impacted by the unique exchange between countries, between cultures, between people that the Peace Corps Niger program has offered. How many times have we heard RPCVs tell us that "I went to Niger to make a difference in someone's life – not knowing that they would make a big difference in my life and help shape my world view." Boston University students seeking an educational exchange with Nigeriens have also returned to the states with the same personal reflection and self-discovery.

Meanwhile from Tapoa and Tillaberi to Zinder, Diffa, and Nguigmi – from Gaya and Konni to Tahoua, Agadez and Iferouane, Nigeriens sitting at home around their TV, campfire, or three cups of tea are still fondly remembering that one American who came and lived with them, for only a little while, helped them see their potential, and lit that one spark that then took them on an individual or village path to where they are today. A path that took them successfully to a place not measured by dollars or CFAs, by number of demi-lunes, wells or clinic beds, or a CEG test score but through the development of problem solving skills, skills that included learning to collaborate so people could work together with other families, other villages and even other ethnic groups to reach a common goal; and equally important, they're remembering that new world outlook that American gave them – no one is alone regardless if they're relaxing under a neem tree, standing on top of a sand dune, or sitting in their canoe on the Niger River, - we're all in this together. This Peace Corps Volunteer gave them the gift of a vision of a world community of belonging to the human family, - and in return we were given a greater appreciation of life's fragility and simple pleasures – what counts in life. During our time in Niger, the important things in life came more into focus for us and for that gift we owe a great debt to the people of Niger.

These gifts we received were meant to be cherished and to be shared. So we remember today that Nigeriens continue to celebrate and share their stories with their children about that awkward American; their stories are only paralleled by the stories we tell our children and friends about these strong, resilient and grounded in faith Nigeriens.

Therefore with great purpose and personal commitment, we the Board of Directors for Friends of Niger along with our members while regretting the suspension of the Peace Corps Niger program and the Boston University-Niger exchange program commit ourselves and our Friends of Niger organization to tirelessly advocate on behalf of the people of Niger to have both the Peace Corps and Boston University programs reopened at the earliest and safest time feasible. We also commit ourselves and our Friends of Niger organization to continue to support and work with our Nigerien and international partners remaining in Niger to fulfill our mission "to improve the lives, health, and well-being of the people of Niger." NIGER ELECTIONS TO RETURN NIGER TO CIVILIAN RULE



On March 14, 2011, BBC News reported that Niger opposition leader Mahamadou Issoufou won the presidential run-off with nearly 58% of the vote. Mr Issoufou had been defeated in two previous polls by former President Mamadou Tandja, who was ousted by the military a year ago. Mr. Issoufou was inaugurated on April 7. The presidential candidate for Mr Tandja's MNSD party, ex-premier Seini Oumarou, received about 42% of ballots. Turnout was about 48%.

Social Democratic Party leader Mr Issoufou, 59, was the favorite going into the run-off, having led the first round of voting in January. The army, which has pledged to step down by April, said before the ballot that it was not backing either candidate.

Mr Tandja spent 10 years in power before being overthrown in a military coup in February last year when he tried to overstay his legal term limit. The former president is currently in prison facing charges of corruption. General Salou Djibo, who has led the junta since its largely popular coup, hailed Saturday's peaceful vote as an example to the rest of Africa.

FON Will Continue to Support Viable Local Institutions in Niger

John Baird traveled to Niger in December to visit old friends and his host family, the family of Mourtallah Idy Gondah (see Camel Express of April 2009). John presented an FON contribution to the Danja Hospital and Leprosarium south of Maradi. The hospital is staffed and funded by a faith-based organization, Serving in Mission (SIM), which also supports Galmi Hospital and several other projects in Niger. Although the Danja facility is huge and growing (and has been there since the 50s), it is not technically called a hospital since they do not have a full time resident physician. Doctors and surgeons come and stay for months at a time. However, within the next year they expect to have at least one resident physician.

The Danja facility has a new physiotherapy building and new eye clinic, and they are in the process of constructing a 42-bed ward for women with obstetric fistula injuries. These injuries occur when a woman is giving birth and isn't able to deliver the baby normally, often because she is too young. In such cases, a woman can be in labor for 4 or 5 days and ultimately needs to have a Caesarean section. When fistula occurs, the resultant injury is an opening between the vagina and the bladder or rectum, causing incontinence. An estimated 100,000 women in that area of Niger and Nigeria have this injury. Danja is partnering with the Worldwide Fistula Fund (WFF) for this work. They've had 4 surgical visits by WFF teams who have operated on 34 women to make the surgical repairs. The Galmi Hospital does these surgeries as well.

FON Provides \$1,200 to Le Pelican School

Le Pelican is a school for mentally and physically challenged children in Baleyara. FON recently provided three months rent for Le Pelican, and the director, Amadou Oueta, sent his heartfelt thanks. Boston University (BU) students working in Niger for a semester included helping at Le Pelican among their duties. A BU student submitted the following:

Santu (Casey Fox) and I (Yakawa) have been volunteering at Le Pelican (the school for disabled kids) in Niamey this semester. It's been a really great experience- there are about 20 kids there on a daily basis, many of whom have Down's Syndrome. It's been so interesting to see the lessons and how much these kids are learning every day. The best part of the whole center though is just how happy the kids seem to be to be in an environment with other kids like them and how cute they are playing and interacting together. Unfortunately, the director, Amadou, came to us the other day and told us that it is looking like they are going to get evicted because they are 7 months behind in rent (not to mention 3 months behind on paying teacher salaries). They used to be supported by a Belgian organization which disbanded last year due to internal discord. Since then, Le Pelican has really been struggling to make ends meet because the kids pay different amounts in tuition based on what their family can afford, and the tuition money does not nearly cover expenses. We are looking for different ways to find money to pay the back rent and hopefully, in the future, be able to help them build a building of their own which would be more cost effective in the long run.

Each summer, the Smithsonian Folklife Festival celebrates the idea of living traditions: concepts or institutions that affect society on an ongoing basis. This year's festival features the legacy of the Peace Corps and its efforts to promote peace. The festival also includes features on the food and culture of Colombia and the history of American rhythm and blues music. The festival is from June 30 to July 11, divided into two five-day segments, with a break for Independence Day. Despite Peace Corps Niger Program Suspension Friends of Niger Continues Local Support

FON continues to work with and support worthwhile grassroots projects in Niger. These include Rencontre et Action, with its microcredit wood burning stove project, and the Organisation pour un Developpement Inclusif (ODI), a small NGO working with handicapped individuals. Most recently, FON provided funds raised through the Jane Huser Maxwell memorial fund to purchase a computer for ODI. Pam White, one of the Sahara Sisters (see Camel Express September 2010 issue) who started the fund, traveled to Niger at her own expense to visit ODI in 2006 and 2008 and has only good things to say about its dynamic director, Harouna Alidou. Harouna has been working with physically and mentally handicapped Nigeriens for 15 years.

Another new FON partner is Project Play Africa (www.projectplayafrica.org), an organization dedicated to improving the lives of children through the sport of soccer. Their focus is West Africa and they were in Niger last month to distribute soccer balls and work with the community of Libore to establish a youth soccer league and a system of clubs. They collaborate with Pencils for Kids, Tobin Mednick, and also partner with Gaston Kaba (Niger Rotary) and Hamani Djibo (Libore) to accomplish their objectives. Dave Stahl and Mike Mitchell, co-founders of Project Play Africa, were in Niamey from March 29 through April 10, staying at the Hotel Terminus. We will have an update of their activities in the next Camel Express.

Other FON partners include the Centre de Santé et Léprologie (see story on page 4) and Galmi Hospital, where Chris Zoolkoski remains our contact. FON is seeking new partners, such as The American Women's Club in Niamey, to fill the significant gaps left by departing volunteers.

Despite Peace Corps Niger Program Suspension Friends of Niger Continues Local Support

FON continues to work with and support worthwhile grassroots projects in Niger. These include Rencontre et Action, with its microcredit wood burning stove project, and the Organisation pour un Developpement Inclusif (ODI), a small NGO working with handicapped individuals. Most recently, FON provided funds raised through the Jane Huser Maxwell memorial fund to purchase a computer for ODI. Pam White, one of the Sahara Sisters (see Camel Express September 2010 issue) who started the fund, traveled to Niger at her own expense to visit ODI in 2006 and 2008 and has only good things to say about its dynamic director, Harouna Alidou. Harouna has been working with physically and mentally handicapped Nigeriens for 15 years.

Another new FON partner is Project Play Africa (www.projectplayafrica.org), an organization dedicated to improving the lives of children through the sport of soccer. Their focus is West Africa and they were in Niger last month to distribute soccer balls and work with the community of Libore to establish a youth soccer league and a system of clubs. They collaborate with Pencils for Kids, Tobin Mednick, and also partner with Gaston Kaba (Niger Rotary) and Hamani Djibo (Libore) to accomplish their objectives. Dave Stahl and Mike Mitchell, co-founders of Project Play Africa, were in Niamey from March 29 through April 10, staying at the Hotel Terminus. We will have an update of their activities in the next Camel Express.

Other FON partners include the Centre de Santé et Léprologie (see story on page 4) and Galmi Hospital, where Chris Zoolkoski remains our contact. FON is seeking new partners, such as The American Women's Club in Niamey, to fill the significant gaps left by departing volunteers.

FON Plans Efforts to Lobby for Reinstatement of Peace Corps Niger

Your Input Needed for a Strategy Meeting in September

Niger is not the first country to experience a Peace Corps suspension due to local unrest. Those of us who love Niger and its people must advocate for a reinstatement as soon and as vocally as possible to attract the attention of Congress and the administration. FON board and members hope to generate substantial interest from supporters as we talk to various decision makers in Washington in September, including Congress and representatives from Senior PC Staff. Supporters of the Bolivia, Sierra Leone, and Liberia programs have undertaken concerted efforts to reinstate their programs, and Peace Corps has just begun a re-entry to Guinea. FON can use learn from their experiences in advocacy.

All are invited to attend an important meeting on September 23 (details not final yet) in Washington, DC, to discuss a strategy for advocating and lobbying for reinstatement of PC Niger, as well as plans to identify and continue support for local NGOs in Niger. FON Funds Nigerien NGOs



The Organisation pour un Développement Inclusif (ODI) is a Nigerien NGO comprised of a small cadre of dedicated individuals assisting Niger's disabled population. Their target population is broadly defined, and includes individuals suffering from blindness, schizophrenia and other mental illness, polio, epilepsy, cerebral palsy, birth defects, and Downs syndrome, among others. Their work has periodically been sponsored by various international NGO's, but the needs far outstrip the funding. Harouna Salifou, the field agent responsible for the Balayera Commune, has been serving the disabled for more than 15 years with a small cadre of dedicated staff. They dispense medication, do physical therapy, educate families about caring for their handicapped members, and help develop gardens to encourage self-sufficiency. Harouna conducts quarterly mental health clinics on market day in Balayera, and travels to 160 surrounding villages on his motorbike. People seek him from as far away as Nigeria.

FON Supports Soccer Program

FON has contributed \$1,000 to an all-volunteer organization, Project Play Africa. The following letter from Jana Tomasello, Marketing Manager, explains the value of the program. If FON gets sufficient funds and support from members, we can expand the program to other regions.

On behalf of Project Play Africa, I would like to thank the Friends of Niger for your generous offer to support our efforts in the community of Libore, Niger. Project Play Africa is a 100% volunteer organization that is dedicated to improving the lives of children through the sport of soccer in Sub-Saharan Africa. We focus on reaching out to rural communities where thousands of children have little opportunity for a better life. The simple gift of a ball represents opportunity – to play, learn and enjoy life on a daily basis. We use a soccer ball as a tool to inspire youth leaders, schools and organizations to develop sports, education and community programs to benefit children. In the 5 years since our inception Project Play has made 3 visits to West Africa – Benin 2010 and Niger in 2008 and 2011. In previous years we worked with the Peace Corps traveling to rural communities to deliver soccer balls. In 2011 without the support of the Peace Corps we were faced with a challenge and were fortunate to be introduced to the community leaders of Libore. Our most recent trip to Libore, Niger has proved to have the greatest impact to date.

Libore is a community of 80,000 located about 20 kilometers from Niamey. This year, with much preparation and advanced coordination, we went to Niger with the goal of setting up a youth soccer league for the community of Libore. Our staff was welcomed by the community with a well-organized plan for discussing establishment of the league, training coaches, and a series of community events to meet and distribute the Project Play soccer balls. We have confidence in the dedicated and competent partners in Libore, in their ability to manage the resources we have provided, and in their willingness to make a lasting impact in their own community. Our greatest hope is that the Libore Premier Soccer League will thrive and that this community will assist Project Play in expanding to other outlying communities in Niger in the future. Project Play created a template for creating a soccer league and club teams that included constitutions, bylaws and training manuals for coaches and referees that can be replicated and utilized to expand the program.

Our proposal for the \$1,000 grant from Friends of Niger is to purchase and ship six sets (different colors) of quality scrimmage vests that would be used for league games. These vests, typically used for scrimmages or practice games in the States, will be a great alternative to team jerseys in Niger. They are cost effective, light weight and durable. The vests will be managed, distributed and collected by the league on game days rather than distributed to the individual children. Six sets of 15 will be enough to field six teams (3 games) simultaneously and ensure a variety of sizes for all age groups.

The intangible benefit is the enhanced experience for the kids and the community. Encouraging teamwork, sportsmanship and leadership is an important aspect to our mission. When the teams come to the field in a colored jersey they will have a sense of belonging and team spirit. This will boost morale and serve to build confidence in the children. It will bring more organization to the game and increase the sense of competition when opposing players are wearing team colors.

In closing, I want mention that like Friends of Niger we are dedicated to continue to maintain and expand our efforts in Libore and beyond in Niger. The roots of our organization are tied to Niger where our co-founder was a Peace Corp Volunteer. We appreciate your interest in Project Play Africa and support in furthering our cause. We look forward to working together to make a difference for the people of Niger.

RPCV Pam White made rounds with Harouna several times in 2006 and in 2008, noting that he exudes caring, acceptance, and patience as he teaches families and encourages self-sufficiency.

There are five field agents total, doing the same work as Harouna in other communes -- plus a few administrators. When their international funding recently suffered a several-month lapse, they organized themselves as an NGO, namely ODI, to carry on their work among Niger's disabled. The Jane Huser Maxwell Memorial Fund provided funding for a laptop computer to assist them, and two Americans living in Niger, Sue Rosenfeld and Steve Anderson, were instrumental in delivering the funds and purchasing the computer on-site in Niamey.

Harouna recently reported on the use of those funds. After purchasing the computer, the remaining money was used for two surgeries - one to correct a young girl's club foot and another to address the after-effects of a disabling injection, as well as a disabled-access ramp for a school in Balayera. Friends of Niger recently elected to contribute an additional \$1,000 to ODI's work, and requested a simple proposal from Harouna. He submitted the following:

Approximately 450,000 CFA will be used to purchase fifteen animals for a small-animal breeding project with five disabled individuals - two ewes and one ram per person. The animals will be held in the name of the disabled person, and provide an income-generation source. All assets provided to the family of a disabled person (land, animals, gardens) are held in the name of that person, reinforcing his or her value to the family and to the community and enhancing that person's self-sufficiency.

Several special chairs will also be commissioned for children with cerebral palsy. Due to their lack of motor control, these children generally spend their lives lying on the ground. The chairs allow them to be strapped in and remain upright throughout the day, significantly enhancing their quality of life. Any remaining funds will be used to purchase medicines for epilepsy and mental illness, to be dispensed, without charge, at the quarterly mental health clinic.

This proposal will directly impact those most in need. The power of these contributions represent grassroots funding at its most effective - funding which directly and positively impacts the lives of Nigeriens. FON funding for the proposal is being hand carried to Niger by former board member Sue Rosenfeld, currently Resident Director, Boston University in Niger Program.

Friends of Niger Continues Local Educational Support

FON has provided a \$1000 donation to continue support of ONEN, a small Nigerian NGO involved in education, including "Second-Chance Schools." The funds were hand-carried to Niger by RPCV and former board member, Sue Rosenfeld. RPCV Pam White has worked closely with ONEN since 2006 and keeps FON up to date on their excellent work. This year, ONEN has proposed a budget that specifically addresses the education of young girls. Additional information about ONEN and its partner, AAWEL in the December 2010 Camel Express. ONEN (Nigerien Organization of Innovative Educators) and its partner AAWEL (Alliance for African Women's Education & Leadership) provide academic and vocational education to young Nigeriens who have been unable to complete school and have achieved great success at several sites in Niamey, and now, with other partners, such as the Swiss NGO Enfants du Monde, in the Tahoua region.

FON Funds New Wood-Conserving Stove Project

Outside of major cities in Niger, nearly 100% of cooking is done over 3-stone open fires, which are wasteful of precious wood resources and dangerous for children. Due to rapid deforestation, women travel ever longer distances from their villages to collect firewood, which is exhausting, time-consuming, and exposes them to potential abduction and abuse.

StoveTec rocket stoves use 50% less fuel. Rachel Rothgery has coordinated the delivery and distribution of an initial load of 1,700 stoves to Niger with the micro-finance initiative of local NGO Rencontre et Action (R&A). R&A has employed 30 women to help with marketing and selling the stoves. FON has donated \$1,000 to R & A for the wood-conserving stove project. John Baird, RPCV and FON board member, visited Niger and oversaw the purchase of 52 stoves to be sold in Maradi.

Since this is a new product, a widespread media campaign, using brochures and radio ads, is planned to promote the use of the stoves, and explain the advantages. Since the stoves are heavy, it is difficult for women to take them house to house for demonstrations, so they will travel through the villages and markets, distributing brochures and encouraging people to come to a central location to view the stoves in operation (see photos below).

FON Supports Soccer Program

FON has contributed \$1,000 to an all-volunteer organization, Project Play Africa. The following letter from Jana Tomasello, Marketing Manager, explains the value of the program. If FON gets sufficient funds and support from members, we can expand the program to other regions.

On behalf of Project Play Africa, I would like to thank the Friends of Niger for your generous offer to support our efforts in the community of Libore, Niger. Project Play Africa is a 100% volunteer organization that is dedicated to improving the lives of children through the sport of soccer in Sub-Saharan Africa. We focus on reaching out to rural communities where thousands of children have little opportunity for a better life. The simple gift of a ball represents opportunity – to play, learn and enjoy life on a daily basis. We use a soccer ball as a tool to inspire youth leaders, schools and organizations to develop sports, education and community programs to benefit children. In the 5 years since our inception Project Play has made 3 visits to West Africa – Benin 2010 and Niger in 2008 and 2011. In previous years we worked with the Peace Corps traveling to rural communities to deliver soccer balls. In 2011 without the support of the Peace Corps we were faced with a challenge and were fortunate to be introduced to the community leaders of Libore. Our most recent trip to Libore, Niger has proved to have the greatest impact to date.

Libore is a community of 80,000 located about 20 kilometers from Niamey. This year, with much preparation and advanced coordination, we went to Niger with the goal of setting up a youth soccer league for the community of Libore. Our staff was welcomed by the community with a well-organized plan for discussing establishment of the league, training coaches, and a series of community events to meet and distribute the Project Play soccer balls. We have confidence in the dedicated and competent partners in Libore, in their ability to manage the resources we have provided, and in their willingness to make a lasting impact in their own community. Our greatest hope is that the Libore Premier Soccer League will thrive and that this community will assist Project Play in expanding to other outlying communities in Niger in the future. Project Play created a template for creating a soccer league and club teams that included constitutions, bylaws and training manuals for coaches and referees that can be replicated and utilized to expand the program.

Our proposal for the \$1,000 grant from Friends of Niger is to purchase and ship six sets (different colors) of quality scrimmage vests that would be used for league games. These vests, typically used for scrimmages or practice games in the States, will be a great alternative to team jerseys in Niger. They are cost effective, light weight and durable. The vests will be managed, distributed and collected by the league on game days rather than distributed to the individual children. Six sets of 15 will be enough to field six teams (3 games) simultaneously and ensure a variety of sizes for all age groups.

The intangible benefit is the enhanced experience for the kids and the community. Encouraging teamwork, sportsmanship and leadership is an important aspect to our mission. When the teams come to the field in a colored jersey they will have a sense of belonging and team spirit. This will boost morale and serve to build confidence in the children. It will bring more organization to the game and increase the sense of competition when opposing players are wearing team colors.

In closing, I want mention that like Friends of Niger we are dedicated to continue to maintain and expand our efforts in Libore and beyond in Niger. The roots of our organization are tied to Niger where our co-founder was a Peace Corp Volunteer. We appreciate your interest in Project Play Africa and support in furthering our cause. We look forward to working together to make a difference for the people of Niger.

RPCV Pam White made rounds with Harouna several times in 2006 and in 2008, noting that he exudes caring, acceptance, and patience as he teaches families and encourages self-sufficiency.

There are five field agents total, doing the same work as Harouna in other communes -- plus a few administrators. When their international funding recently suffered a several-month lapse, they organized themselves as an NGO, namely ODI, to carry on their work among Niger's disabled. The Jane Huser Maxwell Memorial Fund provided funding for a laptop computer to assist them, and two Americans living in Niger, Sue Rosenfeld and Steve Anderson, were instrumental in delivering the funds and purchasing the computer on-site in Niamey.

Harouna recently reported on the use of those funds. After purchasing the computer, the remaining money was used for two surgeries - one to correct a young girl's club foot and another to address the after-effects of a disabling injection, as well as a disabled-access ramp for a school in Balayera. Friends of Niger recently elected to contribute an additional \$1,000 to ODI's work, and requested a simple proposal from Harouna. He submitted the following:

Approximately 450,000 CFA will be used to purchase fifteen animals for a small-animal breeding project with five disabled individuals - two ewes and one ram per person. The animals will be held in the name of the disabled person, and provide an income-generation source. All assets provided to the family of a disabled person (land, animals, gardens) are held in the name of that person, reinforcing his or her value to the family and to the community and enhancing that person's self-sufficiency.

Several special chairs will also be commissioned for children with cerebral palsy. Due to their lack of motor control, these children generally spend their lives lying on the ground. The chairs allow them to be strapped in and remain upright throughout the day, significantly enhancing their quality of life. Any remaining funds will be used to purchase medicines for epilepsy and mental illness, to be dispensed, without charge, at the quarterly mental health clinic.

This proposal will directly impact those most in need. The power of these contributions represent grassroots funding at its most effective - funding which directly and positively impacts the lives of Nigeriens. FON funding for the proposal is being hand carried to Niger by former board member Sue Rosenfeld, currently Resident Director, Boston University in Niger Program.

Friends of Niger Continues Local Educational Support

FON has provided a \$1000 donation to continue support of ONEN, a small Nigerian NGO involved in education, including "Second-Chance Schools." The funds were hand-carried to Niger by RPCV and former board member, Sue Rosenfeld. RPCV Pam White has worked closely with ONEN since 2006 and keeps FON up to date on their excellent work. This year, ONEN has proposed a budget that specifically addresses the education of young girls. Additional information about ONEN and its partner, AAWEL in the December 2010 Camel Express. ONEN (Nigerien Organization of Innovative Educators) and its partner AAWEL (Alliance for African Women's Education & Leadership) provide academic and vocational education to young Nigeriens who have been unable to complete school and have achieved great success at several sites in Niamey, and now, with other partners, such as the Swiss NGO Enfants du Monde, in the Tahoua region.

FON Funds New Wood-Conserving Stove Project

Outside of major cities in Niger, nearly 100% of cooking is done over 3-stone open fires, which are wasteful of precious wood resources and dangerous for children. Due to rapid deforestation, women travel ever longer distances from their villages to collect firewood, which is exhausting, time-consuming, and exposes them to potential abduction and abuse.

StoveTec rocket stoves use 50% less fuel. Rachel Rothgery has coordinated the delivery and distribution of an initial load of 1,700 stoves to Niger with the micro-finance initiative of local NGO Rencontre et Action (R&A). R&A has employed 30 women to help with marketing and selling the stoves. FON has donated \$1,000 to R & A for the wood-conserving stove project. John Baird, RPCV and FON board member, visited Niger and oversaw the purchase of 52 stoves to be sold in Maradi.

Since this is a new product, a widespread media campaign, using brochures and radio ads, is planned to promote the use of the stoves, and explain the advantages. Since the stoves are heavy, it is difficult for women to take them house to house for demonstrations, so they will travel through the villages and markets, distributing brochures and encouraging people to come to a central location to view the stoves in operation (see photos below).

Maman Sidikou Appointed Nigerien Ambassador to the U.S.

Maman Sidikou has been appointed the new Ambassador of the Republic of Niger to the United States. Mr. Sidikou received his Ph.D in adult and nonformal education from Florida State University in 1994, with former Peace Corps volunteer Peter Easton as his advisor. He also has an M.A. from the University of Texas at Austin in Communication, a D.S. in journalism from the Universite de Dakar and an A.A. from the Universidad de Madrid.

His most recent position (2010, 2011) was in the Democratic Republic of Congo as country director for Save the Children, UK, coordinating integrated programming for health, protection and integration. From 2007 to 2010 he was Chief, Education for UNICEF in Nigeria. He was also UN Cluster Coordinator for Education and Culture for the UNICEF Programme Irak in Amman, Jordan and worked for the World Bank in Washington, DC from 2002 to 2005 as a Senior Education Specialist. He has held other UNICEF and USAID positions in Afghanistan, Nigeria and Niger. In the late 90's, as well as the early 80's he worked for the government of Niger. In 1999 he was the Minister, Director of Cabinet, Presidency, where he coordinated relations between the Presidency and the Office of Prime Minister.

We (the Friends of Niger) are looking forward to meeting Mr. Sidikou soon.

Former Niger President Ali Saibou Has Died

Ali Saibou, who was president of Niger from 1987 to 1993 died Monday, October 31, 2011 in Niamey at the age of 71. Three days of national mourning were declared to honor Saibou who was buried in his native village of Dingajibanda, near Ouallam, in western Niger.

In 1987 Saibou was appointed to succeed president Seini Kountche who had died of cancer. In 1989, under a new constitution, Saibou ran and won as the only candidate for President. Two years later he authorized a national conference that led to the dawn of multi-party politics.

Friends of Niger signed the Niger Embassy book of condolences.

Kathleen K. Bishop, Engineer, Diplomat's Wife

Kathleen K Bishop, 64, a mechanical engineer who accompanied her husband on diplomatic tours to Niger, Liberia and Somalia, died September 29, 2011, at her home in Washington, DC. She had brain cancer according to her husband, retired Ambassador James K. Bishop.

As the wife of an ambassador, Mrs. Bishop met with local African officials, helped organize community events and aided health organizations and women's groups. She received a certificate of appreciation from the State Department for her services to the American communities in Monrovia and Mogadishu during the conflicts in Liberia and Somalia.

FON Thanks the Students of Lake Area Schools in Illinois

FON received a donation of \$200 from the Village Elementary School in Round Lake, Illinois. Sheila Miller, a Social Worker at the school and the mother of a Boston University student (Kelley Miller) who was in the BU program in Niger in 1999 and later served as a PCV in Mali ('00-'02), proposed the Young Girls Scholarship Program as a service project and the students agreed it was a great idea to send a young girl to school in Niger. The class of Learning Disabled children raised the money during the 2010-2011 school year. Although the Young Girls Scholarship Program supported by FON is suspended, the funds were donated to an FON partner, AAWEL (Alliance for African Women's Education & Leadership) to ensure a young girl's education.

After a brief reception at the Embassy, the discussions continued at the home of Penni St.Hilaire and Tommy Tomlinson in NW Washington. Thanks to Penni and Tommy's generous hospitality, the 40 guests, FON members and others interested in Niger, enjoyed sharing a wonderful array of food, fellowship and reminiscences, forming new relationships and rekindling old ones.

The FON dinner at the Bukom Café, which serves delicious West African food, was held the following evening. So many people attended that both the upper and lower dining areas of the restaurant were made available to our group. The conversation and fellowship continued with people who had attended the other events as well as new people who were able to join us.

On Sunday, many Niger RPCVs attended the closing ceremony at Arlington National Cemetery to commemorate the 180 volunteers who died in service, followed by the Parade of Flags, arranged alphabetically. We gathered excitedly around the Niger flag and walked across the Memorial Bridge to the Lincoln Memorial, where we disbanded. No one seemed to mind that there were no parade watchers – the spirit and energy was from us and for us, and for those being honored. It was a fitting end to our celebration of the 50th anniversary of the Peace Corps.

I loved my host family but, as time wore on, I became more frustrated with the lack of infra-structure, the crowded and bone rattling bush taxi rides to market, the abject poverty, and the cultural barriers. But there was a sense of community in rural Niger, where everyone knew everyone else and every birth, death, marriage, and baptism in the village was common knowledge. When hunger season rolled around every year, everyone shared the little they had and no one let their friends fall through the safety net. By far, the best thing about Gandassamou was my host father, El Hadji Issa, a sprightly man in his sixties. He insisted that I accompany him to the fields to see the emerald shoots of millet and sorghum emerge, fixed my mud house when it leaked, told his family to set aside *tuwo* for me every night, and gave me fresh carrots, lettuce, and tomatoes from his gardens.

The security situation in Niger got more and more precarious as my service continued in Gandassamou. It started with the kidnapping and killing of foreigners near the Nigerien-Malian border earlier in 2009 by Al-Qaeda in the Islamic Maghreb (AQIM). Later in December 2009, I was evacuated from Gandassamou because of a security threat in Tahoua, our regional capital—there was an attempted kidnapping of staffers who were working for the American embassy. Peace Corps evacuated the Tahoua region in its entirety, and I was moved to another village near Gidan Rumji called Dan Turke. There I renovated the local primary school, organized women’s literacy classes, made fast friends with the village chief and his family, established a farmer field school to experiment with different bean varieties, made the young men laugh with insulting rejections of their marriage proposals, and caught malaria. It was the most productive and joyous time in my entire service.

I officially closed service on December 10, 2011. A few weeks after I left, two French nationals were kidnapped at Toulousain’s (aka Ebenezer’s), a favorite bar haunt of Peace Corps volunteers—which also happened to be located right near our hostel. Thankfully, no volunteers were present there at the time of the kidnapping. Peace Corps decided it was time to suspend the program and evacuate the volunteers—it seemed Al-Qaeda was on our doorstep. The evacuation was devastating for the volunteers and staffers who lived and worked throughout Niger; everyone had formed strong bonds with their host families, their coworkers, and the Nigerien staff.

My friends who were evacuated from Niger were unhappy with how Peace Corps handled the process. Volunteers were given four days to close their service, which usually takes 2 weeks—1 week of career and readjustment training, which takes place 3 months before service ends and 1 week of paperwork and medical exams at the close of service. The transition conference was rushed and stressful. Many volunteers expressed interest in continuing to serve in another country, but only a third were given the

The best and most enduring friendships I’ve ever had were forged with other volunteers during my time in the Peace Corps. My quick readjustment and subsequent employment with the government could not have happened without the support of the RPCV community and the connections I made while in the Peace Corps. Peace Corps was and will always be the most important and the best thing I’ve ever done.

Reinstatement of Peace Corps in Niger

As reported elsewhere, the primary issue related to the return of Peace Corps to Niger is the concern of safety. Even before the program suspension there were incidents in several places with Al-Qaeda in the Islamic Mahgreb and other organizations causing Peace Corps to bring volunteers closer to Niamey. We do not believe that the concerns about safety are gone. Critical also is getting the U.S. Ambassador's endorsement. We have been in contact with Ambassador Williams and hope to meet with her when she is in town before Christmas. She assures FON that she is 100% in favor of a resumed Peace Corps presence in Niger and will support efforts leading to that outcome. She also strongly suggests that FON start at the Peace Corps Agency, which we will do.

Ten people signed up to participate on a committee to develop strategies for the return of Peace Corps. Even after it is deemed safe in Niger, we could run into budget problems if Peace Corps decided they do not have adequate funding for a program in Niger. For those of us that think Peace Corps Niger is a vital program we will likely need to lobby of our Representatives and Senators. We hope you will join us. We will be contacting those who volunteered to be on the committee after the first of the year to discuss, by email or conference call, actions we can take for the return of Peace Corps.

Reinstatement of Peace Corps Niger Supported by Ambassadors

Both the American Ambassador to Niger, Bisa Williams, and the new Nigerien Ambassador to the U.S., Maman Sidikou, have expressed their support for efforts to eventually reinstate Peace Corps in Niger. FON's well-attended meeting at the Niger Embassy in honor of the 50th Anniversary went a long way to drawing attention to the issue and to mobilizing the grass roots support those of us who love Niger. Much remains to be done to ensure the security of volunteers, but it is heartening to know that both Ambassadors see it as a priority. Indeed, Ambassador Sidikou has been at his post in Washington, DC less than two weeks and has already set up a meeting with Peace Corps Washington. In addition, he will meet with FON Secretary Penni St. Hilaire on December 12. Ambassador Williams offered to be available to FON and stated she is "100% in favor of a resumed PC presence in Niger and will support efforts leading to that outcome."

Update on Galmi Hospital

from Dr. Christopher D. Zoolkoski, MD, RPCV Tahoua '88-90

Our international medical team in Galmi is working hard to provide accessible and quality healthcare to the poorest of Niger. We're treating 300 patients per day through our outpatient department. The majority of our 110 beds are usually full. The number of malaria cases is thankfully starting to decline and we are seeing more of the cold season illnesses such as pneumonia and flu-like illnesses. Our surgeons are performing 20 cases daily for obstetrical emergencies, intestinal typhoid perforations, urinary obstruction, skin grafting for burns, and fractures from trauma. We are currently seeking funding for replacement of our antiquated x-ray unit. There are currently 18 children receiving care in our CREN (our malnutrition rehabilitation center) and we are prepared to admit more as needed. One CREN patient is a 1 year old HIV positive boy who came as a skeleton with no strength to drink.

Following careful nasogastric feeding and initiation of antiretroviral therapy he can now hold up his head but we still have a ways to go to improve his nutritional status. We are thankful to the Nigerien Ministry of Health and the DRSP of Tahoua for their support and collaboration in helping us with many of our needs related to malnutrition, malaria, HIV, TB, and family planning. Thank you, also, to Friends Of Niger for the generous donations of children's chewable multivitamins which are helping many undernourished children. The container with your last donation of vitamins has arrived and the vitamins are being put to good use!

Maman Sidikou Appointed Nigerien Ambassador to the U.S.

Maman Sidikou has been appointed the new Ambassador of the Republic of Niger to the United States. Mr. Sidikou received his Ph.D in adult and nonformal education from Florida State University in 1994, with former Peace Corps volunteer Peter Easton as his advisor. He also has an M.A. from the University of Texas at Austin in Communication, a D.S. in journalism from the Universite de Dakar and an A.A. from the Universidad de Madrid.

His most recent position (2010, 2011) was in the Democratic Republic of Congo as country director for Save the Children, UK, coordinating integrated programming for health, protection and integration. From 2007 to 2010 he was Chief, Education for UNICEF in Nigeria. He was also UN Cluster Coordinator for Education and Culture for the UNICEF Programme Irak in Amman, Jordan and worked for the World Bank in Washington, DC from 2002 to 2005 as a Senior Education Specialist. He has held other UNICEF and USAID positions in Afghanistan, Nigeria and Niger. In the late 90's, as well as the early 80's he worked for the government of Niger. In 1999 he was the Minister, Director of Cabinet, Presidency, where he coordinated relations between the Presidency and the Office of Prime Minister.

Former Niger President Ali Saibou Has Died

Ali Saibou, who was president of Niger from 1987 to 1993 died Monday, October 31, 2011 in Niamey at the age of 71. Three days of national mourning were declared to honor Saibou who was buried in his native village of Dingajibanda, near Ouallam, in western Niger.

In 1987 Saibou was appointed to succeed president Seini Kountche who had died of cancer. In 1989, under a new constitution, Saibou ran and won as the only candidate for President. Two years later he authorized a national conference that led to the dawn of multi-party politics.

I loved my host family but, as time wore on, I became more frustrated with the lack of infra-structure, the crowded and bone rattling bush taxi rides to market, the abject poverty, and the cultural barriers. But there was a sense of community in rural Niger, where everyone knew everyone else and every birth, death, marriage, and baptism in the village was common knowledge. When hunger season rolled around every year, everyone shared the little they had and no one let their friends fall through the safety net. By far, the best thing about Gandassamou was my host father, El Hadji Issa, a sprightly man in his sixties. He insisted that I accompany him to the fields to see the emerald shoots of millet and sorghum emerge, fixed my mud house when it leaked, told his family to set aside *tuwo* for me every night, and gave me fresh carrots, lettuce, and tomatoes from his gardens.

The security situation in Niger got more and more precarious as my service continued in Gandassamou. It started with the kidnapping and killing of foreigners near the Nigerien-Malian border earlier in 2009 by Al-Qaeda in the Islamic Maghreb (AQIM). Later in December 2009, I was evacuated from Gandassamou because of a security threat in Tahoua, our regional capital—there was an attempted kidnapping of staffers who were working for the American embassy. Peace Corps evacuated the Tahoua region in its entirety, and I was moved to another village near Gidan Rumji called Dan Turke. There I renovated the local primary school, organized women’s literacy classes, made fast friends with the village chief and his family, established a farmer field school to experiment with different bean varieties, made the young men laugh with insulting rejections of their marriage proposals, and caught malaria. It was the most productive and joyous time in my entire service.

I officially closed service on December 10, 2011. A few weeks after I left, two French nationals were kidnapped at Toulousain’s (aka Ebenezer’s), a favorite bar haunt of Peace Corps volunteers—which also happened to be located right near our hostel. Thankfully, no volunteers were present there at the time of the kidnapping. Peace Corps decided it was time to suspend the program and evacuate the volunteers—it seemed Al-Qaeda was on our doorstep. The evacuation was devastating for the volunteers and staffers who lived and worked throughout Niger; everyone had formed strong bonds with their host families, their coworkers, and the Nigerien staff.

My friends who were evacuated from Niger were unhappy with how Peace Corps handled the process. Volunteers were given four days to close their service, which usually takes 2 weeks—1 week of career and readjustment training, which takes place 3 months before service ends and 1 week of paperwork and medical exams at the close of service. The transition conference was rushed and stressful. Many volunteers expressed interest in continuing to serve in another country, but only a third were given the

Projects Currently Supported by FON

Even though PC Niger has been suspended, FON continues to partner with local organizations to fund worthwhile, sustainable projects. In addition to Galmi Hospital, featured on page 8, these are current projects. Partner funding organizations include RAIN for the Sahel and the Sahara and The Jane Huser Maxwell Memorial Fund, Boston University, and Northeastern University.

ODI: The Organisation pour un Développement Inclusif (ODI) is a Nigerien NGO comprised of a small cadre of dedicated individuals assisting Niger's disabled population, helping those suffering from blindness, schizophrenia and other mental illness, polio, epilepsy, cerebral palsy, birth defects, and Downs syndrome, among others.

ONEN: ONEN (Nigerien Organization of Innovative Educators) and its partner AAWEL (Alliance for African Women's Education & Leadership) provide academic and vocational education to young Nigeriens who have been unable to complete school.

AAWEL: Second-Chance School program focuses on academic empowerment (language and math literacy) and the integration of vocational/life skills and leadership skills, preparing students for a productive life.

Amadou Hampaté Bâ School: Collège Amadou Hampaté Bâ is a private, coeducational, non-denominational secondary school in a popular neighborhood in Niamey called Dar-es-Salam.

Rencontre et Action: A local microcredit NGO staffed entirely by volunteers, R & A includes a wood burning stove project marketing stoves that use 50% less fuel.

Children's Chewable Vitamins: Purchased in the U.S. by FON staff, these vitamins are hand carried to hospitals in Niger by FON members or Boston University students.

Project Play Africa: A 100% volunteer organization that is dedicated to improving the lives of rural children through the sport of soccer in Sub-Saharan Africa.

Le Pelican School: A school for mentally and physically challenged children in Baleyara.

Danja Hospital and Leprosarium: The Danja facility, which partners with the Worldwide Fistula Fund, provides surgical procedures for women with obstetric injuries

Other Partners & Projects: Plumpy'nut Project, Saabu Dey Well Project, Project ABC Schools, and Estrogenius Festival's Voices of Africa.
